Solid Waste Management Rules, 2016

Citizens are expected to do the following:

1. Segregate the waste in separate bins like bio-degradable, non bio-degradable and domestic hazardous waste.



2. Sanitary napkins / diapers shall be packed in a pouch / Paper with 'X' red symbol & hand over separately.
3. Practice in house composting, vermi-composting, bio-gas generation or community level compost.

Plastic Waste Management Rules, 2016

What to do?

1. Avoid throwing plastic garbage, collect & give it to the waste Recycler / Reprocessor
2. Use a cloth or other re-usable bag while shopping

Construction and Demolition Waste Management Rules, 2016

What to do?

1. Construction & Demolition waste shall not be mixed with Solid Waste
2. Segregate construction and demolition waste and deposit at collection centre or handover it to the authorised processing facilities
3. No littering or deposition so as to prevent obstruction to the traffic or to public or to drains.
4. Identify site for dumping construction and demolition waste in each town/ village

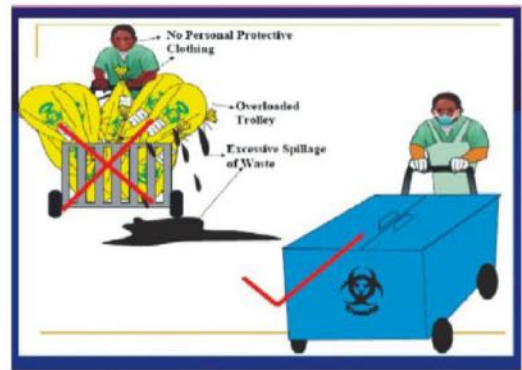
Where & How to Dispose?

All the C & D waste may be sent to the place which is identified by the concerned local bodies by the respective waste generator at their own cost. In Puducherry, the waste generators may send their C&D waste to Mettupalayam Truck Terminal, which belongs to the Oulgaret Municipality.

Bio-Medical Waste Management Rules, 2016

Health care Facilities / Hospitals are expected to do the following ?

1. Don't mix the Solid Waste and Biomedical Waste.
2. As per the above Rules, Biomedical waste shall be categorised into four types and hand over to Common Biomedical waste Treatment Facility (CBMWTF).
3. Don't dispose waste in open place.
4. Waste water from hospitals must be treated and discharged into the canals.
