Workshop Summary

The Puducherry Climate Change Cell (PCCC) under the Department of Science, Technology and Environment, Puducherry, organized the Training Workshop on "Climate Change Strategies and Finance Mechanisms" with the aim of sharing information and best practices about climate change funds and in helping government agencies to build their capacity in accessing the existing pool of climate change finance from various sources. The workshop was supported by the Department of Science and Technology, Govt. of India and NABARD.

The Training Workshop was aimed at sensitizing the government officials and other stake holders on climate change issues of Puducherry Union Territory and to help them identify mitigation and adaptation needs, formulate suitable mitigation and adaptation action plans and access climate finance for climate change actions.

The Training Workshop was aimed at explaining the present global climate change scenario and climate change impact at national and regional level with specific reference to Karaikal. The National and State Climate Change Action Plans and the corresponding mitigation and adaptation actions that are under formulation or under implementation were also discussed along with various funding mechanisms available for climate change projects like National Adaptation Fund for Climate Change (NAFCC) and Green Climate Fund (GCF).

The training program was conducted with following major objectives:

- i) Climate Change Context in the UT of Puducherry with special reference to Karaikal.
- ii) Overview of Climate Change Finance & available funding mechanism.
- iii) Overview of NAFCC funding process and project formulation methodology.
- iv)Introduction to the GCF funding process and project formulation methodology.
- v) Brain storming session to identify suitable project proposals for Karaikal region for funding under NAFCC / GCF schemes.

Inaugural Function

introduced the Chief Guests on stage to the participants and gave a brief introduction about the training workshop.

Inaugural Address:

The District Collector -cum- District Magistrate of Karaikal, Shri. R. Kesavan I.A.S., gave the Inaugural Address for the training workshop. He introduced the audience with the global scenario of Climate Change and also gave a detailed narration of the international governing bodies that work on Climate Change. He has also discussed the ideas, plans and researches that are undertaken by these International governing bodies to co-

ordinate the countries of the world in working towards the rising concerns of the present Climate Change scenario.



Special Address:



The Hon'ble Minister of Agriculture, Shri. R. Kamalakannan stressed the fact that the growing of concern Climate Change is evident in the recent times with the increasing number of news in the mass media

and social media. He shared his knowledge on the natural and anthropogenic causes that is causing the present Climate Change impacts and urged that the general public should be more aware of the Climate Change impacts and should commit themselves towards bringing in life style changes that would mitigate Climate Change.

Presidential Address:

The Hon'ble Minister of Science, Technology and Environment, Shri. M. Kandasamy, addressed the gathering with a note on the significance of the Department of Science, Technology and Environment's interest



in organizing such a Training Workshop and emphasized that such initiatives on working towards Climate Change are the need of the hour. The Minister said that several projects that could effectively improve the environment and livelihood of the people of Karaikal can be brought about with such Training Workshops with the aim of making Karaikal less vulnerable to impacts of Climate Change. The Minister announced that Rejuvenation of 25 Tanks and 32 Ponds is now under implementation in the region of Puducherry and soon such Rejuvenation project would be planned for the Tanks and Ponds in the region Karaikal as well.

Technical Session

Session 1: "Climate Change Context in the UTP with special reference to Karaikal"

The Junior Engineer from the Department of Science, Technology and Environment Mr. K. Kalamegam gave a detailed presentation Climate Change, on wherein he introduced Climate Change defined by international governing



bodies such as IPCC, NASA working on Climate Change and also gave introduction on Climate Change for the better practical understanding of the participants. He elaborated on the pressing issues of Climate Change, the various natural and anthropogenic causes that are causing Climate Change and its impacts and effects on the global population in the present time. He also stressed on the seriousness that Climate Change could bring in the livelihood of people in the near future and gave a precise comparison of the effects of climate change if the global average temperature continues to rise by 1.5°C - 2°C in the coming years. He then discussed the Climate Change scenarios pertaining to Karaikal region and the impacts and vulnerabilities that the region of Karaikal is prone to in the coming years. As a note of conclusion, he explained the Climate Change scenarios specific to India and the way the Government of India and the Puducherry Climate Change Cell under the Department of Science, Technology and Environment, Puducherry is working on various adaptation and mitigation programs as a measure of combating Climate Change.

Session 2: "Overview of Climate Change Finance & available funding Mechanism"

Ms. Shyampriya, Assistant General Manager, NABARD presented on Formulation of project under NAFCC. Shyampriya shared information on NABARD and its commitment towards Rural Development Impact and of Climate Change on



Rural Economy and Agriculture. She then elaborated on the details of the topic "Climate Financing" and India's requirement of finance in terms of Climate Change and categorically explained the Domestic Financing Mechanism and the International Financing Mechanism. Various projects taken up by NABARD that are under progress across the states of India were also explained categorizing them on the basis of Adaptation or Mitigation projects. She also gave a gist of leveraging of additional capital under various other funds that could be availed in case if required for the completion of any project.

Session 3: "Overview of NAFCC funding process and project formulation Methodology"

Ms. Shyampriya, Assistant General NABARD Manager, presented on Formulation of project under NAFCC. Firstly, Ms. Sam Priya, AGM, NABARD, shared complete information NAFCC Project on Formulation, the right



way of approaching NAFCC with a project proposal, the proper ways of formulating a project before proposing to NAFCC, the right proposals that would get through NAFCC funding scrutiny, and the method of fund disbursement by NAFCC for the proposed project. She then gave a detailed step by step procedure that should be followed in project proposals, starting from Project/Programme Information, Project/Programme Justification and Implementation Agreement. She then summed up her presentation with information such as Knowledge Management for a project, Stakeholder Consultation, Risk Management, Monitoring and Evaluation arrangements, Budget Disbursement schedule and Result frameworks.

Session 4: "Introduction to the GCF funding process and project formulation methodology"

The Resource Person Mr. Mashar, Deputy General Manager, NABARD presented Climate on **Financing** Mechanisms with topics covering Accessing GCF Funding **GCF** and Project Formulation. Also. Mr. Mashar gave a detailed



introduction on the Green Climate Fund, the basics of India's requirement for Climate financing, the protocols to be followed in accessing GCF Funding, the way GCF categorizes a project based on the size of the project which inturn depends on the total projected cost for the project. He then gave detailed information on the method of preparing Detailed Project Report (DPR) for project to be proposed for GCF funding, overview of project approval process by GCF.

Interactive Session:

An interactive brainstorming session was facilitated by Mr. Mashar, Deputy General Manager, and NABARD with the participants of the training workshop. In this session, Mr. Mashar gathered a list of projects that could be taken up for Karaikal based on the suggestions from the participating Government Officials and presented the list on stage. He then guided the participants by mapping a particular project with several project proposal criteria such as selecting the better funding agencies namely GCF or NAFCC, and the choice of bringing the project under Adaptation or Mitigation activity etc.

Session 5: "Brainstorming session to identify suitable project proposals for Karaikal region for funding under NAFCC / GCF schemes"

The officials from the Department of Science, Technology and Environment, Dr. Sagaya Alfred, Senior Scientific Officer and Mr. K. Kalamegam, Junior Engineer along with the officials from



NABARD, Mr. Mashar, Deputy General Manager, Ms. Shyampriya, Assistant General Manager, Chennai and Ms. Uma Gurumurthy, Assistant General Manager, Puducherry, chaired a Brainstorming session with the participants. The floor was opened for suggestion on projects that could be taken up in Karaikal under Climate Change action plan. Following adaptation projects were suggested by the participants:

- i) Interlinking of Lakes and River Tributaries in Karaikal region.
- ii) Interlinking of Puravadayar River with Arasalar River.
- iii) Renovation of irrigation canals from the upstream of the river to the end usage in agricultural lands.
- iv) Channelizing sewage to avoid sewage intrusion into the irrigation channels
- v) Tank renovation by dredging and desilting for proper storage of surface water during monsoon and hence groundwater recharge.
- vi) Banning the manufacture and use of plastic bag. Replacing Plastic Bags with Jute Bags and training for the manufacture and production of alternatives like Jute Bags.
- vii) Farm Forestry was suggested as one of the Mitigation project for Climate Change in Karaikal.
- viii) Coastal Ground Water Recharge and ban on borewell along the coastal region with immediate effect, as water table was well below 300 m in the present time.

- ix) Mangroves restoration and studies on species conservation of mangroves
- x) Artificial Coral Reef planting in the sea for the lost coral reefs near Karaikal shores.
- xi) Roof Top Solar Panel projects.
- xii) Underground Electrical Cables laying in Karaikal as the regon s highly vulnerable to cyclones and other coastal disasters.
- xiii) Rainwater Harvesting in every domestic and commercial complex.
- xiv) Climate Change Awareness programmes to be conducted under "Climate Literacy Program" of NABARD.

Conclusion:

The officials from various departments and sectors participated in the Training Workshop. The session was very productive with the participating officials getting hands on in upcoming project proposals starting from project formulation, preparing the Preliminary/Detailed Project Report (PPR/DPR) to undergoing various project approval negotiations with the funding agencies, implementing agencies and the Central Ministry.
