# MINUTES OF THE 31<sup>st</sup> MEETING OF THE PUDUCHERRY COASTAL ZONE MANAGEMENT AUTHORITY HELD ON 09.01.2015 AT 03.00 P.M. IN THE CONFERENCE HALL OF PHB BUILDING, ANNA NAGAR, PUDUCHERRY.

The 31<sup>st</sup> meeting of the Puducherry Coastal Zone Management Authority was held on 09.01.2015 under the Chairmanship of Dr. V. Candavelou, I.A.S., Commissioner - cum - Secretary to Govt. (Science, Technology and Environment) – cum - Chairman (PCZMA). The following were present:-

With the permission of Commissioner - cum - Secretary (Environment) -cum-Chairman (PCZMA), the Member Secretary welcomed the members and other officers present. The agenda was taken up for deliberation. All the proposals were placed before the Authority for perusal and the issues were deliberated as per the Agenda and decisions are as follows:

## Agenda Item No. 1: Issue of CRZ Clearance for PIA- Electrical Division – Laying of UG cable in the coastal area of Puducherry region under CDRRP scheme

The Authority heard the proposal and discussed the subject in detail. Dr. G. Poyyamoli, Associate Professor, Department of Environment and Ecology, Pondicherry University – Environmental Consultant for the project made a presentation on the Environmental and Social Impact Assessment of the project. The Authority observed that the project would reduce electricity down time during any extreme weather events like cyclones and would be extremely beneficial to the coastal communities. After due deliberation, the Authority resolved to accord clearance for the project subject to the following conditions:

- i) All the recommendations made in the Environmental and Social Assessment Report prepared by Department of Ecology and Environment, Pondicherry University for the project shall be scrupulously followed.
- ii) The activities should not cause any adverse impact on the nearby ecology/biodiversity.
- iii) Proper arrangements shall be made for disposal of solid wastes generated during laying operation.
- iv) All activities should be in conformity with the provisions of the CRZ Notification, 2011.
- v) The project proponent shall submit bi-annual report on the project progress to PCZMA.

## Agenda Item No. 2: Issue of CRZ Clearance for construction of provision of Berthing and Allied Facilities and High Security compound wall in Coast Guard Land at Veerampattinam.

The Authority heard the proposal and discussed the subject in detail. After due deliberation, the Authority observed that the proposal is basically required for coastal and maritime security and resolved to accord clearance for the project subject to the following conditions:

- i) Compound wall and facilities essential for safe berthing of Hover Crafts shall only be constructed. No other permanent structures shall be constructed. Only temporary Eco Friendly structures to be constructed for the auxiliary uses.
- ii) The activities should not cause any adverse impact on the nearby ecology/biodiversity.
- iii) There should not be any ground water extraction in CRZ areas.
- iv) No untreated waste water shall be discharged in the Coastal Regulation Zone.
- v) Proper arrangements shall be made for disposal of solid wastes and there shall not be any dumping of solid waste in CRZ areas.

- vi) All activities should be in conformity with the provisions of the CRZ Notification, 2011.
- vii) The project proponent shall submit bi-annual report on the project progress to PCZMA.

## Agenda Item No. 3: Issue of CRZ Clearance for construction of M/s. Alpha Matriculation Higher Secondary School, Thengaithittu

The Authority heard the proposal and discussed the subject in detail. After due deliberation, the Authority resolved to recommend the proposal to Puducherry Planning Authority for approval subject to the following conditions:

- i) The proposed construction shall be beyond 100 meters or the width of the tidal influenced water body, whichever is less.
- ii) The buildings shall only be for Higher Classes.
- iii) The buildings shall be at higher elevation.
- iv) Building Plan parameters shall be in conformity with the existing Town and Country Planning Regulations including the existing norms of Floor Space Index or Floor Area Ratio.
- v) There should not be any ground water extraction in CRZ areas.
- vi) No untreated waste water shall be discharged in the Coastal Regulation Zone.
- vii) Proper arrangements shall be made for disposal of solid wastes and there shall not be any dumping of solid waste in CRZ areas.
- viii) All activities should be in conformity with the provisions of the CRZ Notification, 2011.
- ix) The project proponent shall submit bi-annual report on the project progress to PCZMA.
- x) The project proponent shall obtain necessary clearance from PPCC.

#### Agenda Item No. 4: Issue of CRZ Clearance for Puducherry Mahatma Gandhi Green Development Project proposed by Puducherry Environment and Mangrove Forest Development & Protection Society

The Authority heard the proposal and discussed the subject in detail. After due deliberation, the Authority resolved to return back the project proposal as the same has not been filed by the road / land – owning Authority.

Agenda Item No. 5: Issue of CRZ Clearance for carrying out repair / replacement and modification of exiting marine discharge pipeline of M/s. Chemfab Alkalis Limited, Kalapet, Puducherry

This is a pre -1991 unit and the marine discharge pipelines were laid before the advent of CRZ Notification, 1991. The unit has obtained necessary Air and Water Consent Authorization / Renewal from the time to time since 1991 and the latest being on 17.12.2013. In this backdrop, the authority considered the proposal and observed that the Project Proponent is seeking a blanket Clearance for future repair / replacement and modification works in the existing marine discharge pipeline of the industry. After due deliberations, the Authority resolved to return back the project proposal with a direction to apply for clearance as and when the need for repair /replacement / modification of discharge communicated vide letter No. marine pipeline arises, as 9/DSTE/PCZMA/DIR/JE/2014/584 dt. 26.12.2014

Agenda Item No. 6: Issue of CRZ Clearance for carrying out repair / replacement and modification of exiting marine outfall system of M/s. Shasun Pharmaceuticals Limited, Kalapet, Puducherry.

This is a pre – 1991 unit and the marine discharge pipelines were laid before the advent of CRZ Notification, 1991. The unit has obtained necessary Air and Water Consent Authorization / Renewal from the time to time since 1991 and the latest being on 14.11.2014. In this backdrop, the authority considered the proposal and observed that the Project Proponent is seeking a blanket Clearance for future repair / replacement and modification works in the existing marine discharge pipeline of the industry. After due deliberations, the Authority resolved to return back the project proposal with a direction to apply for clearance as and when the need for repair /replacement / modification of marine discharge pipeline arises, as communicated vide letter No9/ DSTE/ PCZMA/ DIR/JE/2014/584 dt. 26.12.2014

## Agenda Item No. 7: Issue of CRZ Clearance for Alteration and Addition in the existing three storied commercial building (Guest Room) by Thiru. Tillai Velou

The Authority heard the proposal and discussed the subject in detail. After due deliberation, the Authority resolved to recommend the proposal to Puducherry Planning Authority for approval subject to the following conditions:

- iv) Proper arrangements shall be made for disposal of solid wastes and there shall not be any dumping of solid waste in CRZ areas.
- v) All activities should be in conformity with the provisions of the CRZ Notification 2011.
- vi) The project proponent shall submit bi-annual report on the project progress to PCZMA.
- vii) The project proponent shall obtain necessary clearance from PPCC.

## Agenda Item No.9: Status Review of implementation of Coastal Regulation Zone Notification, 2011 in Puducherry

The Authority was appraised about the action taken in compliance with the decisions taken in the  $30^{th}$  PCZMA meeting held on 10.06.2014. After due deliberation the Authority decided the following:

## Agenda Item No. 10: Report on National Strategy for Coastal Erosion – For remarks and comments

The Authority heard the proposal and discussed the subject in detail. The Authority noted that a letter has been sent by MS-PCZMA on 02.01.2015 to Chief Engineer - PWD to work out the necessary shoreline management plan and shoreline protection measures in line with the Report on National Strategy for Coastal Erosion and Shoreline Changes Maps prepared by MoEF & CC and in consultation with all the stake holders including Government of Tamil Nadu officials of the adjoining Tamil Nadu Coast. After due deliberation, the Authority resolved to write similar letter to Government of Tamil Nadu requesting them to consult Government of Puducherry on all their shoreline management projects proposed in the neighbouring coastline and to evolve a common shoreline management plan.
