The Revision of Scrutiny / Processing fees for issuance of Coastal Regulation Zone Clearance as per the CRZ Notification, 2011 /2019 was placed in the 55th Meeting of Puducherry Coastal Zone Management Authority (PCZMA) vide reference (2) cited above. The Authority decided to revise the CRZ Scrutiny/Processing Fees by enhancing the existing fee structure as follows:

The modified / revised fee structure for issuance of CRZ clearance is subject to the following conditions:

1. The fee structure is applicable to all Government and Private Investment Projects in the U.T. of Puducherry.
2. This order shall come into force with effect from the date of issue.
3. The Project Proponent(s) shall pay only 25 % of the total fees as initial payment for processing the application which is Non-refundable.
4. The Project Proponent(s) shall pay the remaining 75% of the total fees, once the proposal is cleared / recommended by PCZMA.
5. CRZ Clearance / Recommendation will be issued by PCZMA to the Regional Planning Authorities, State Environment Impact Assessment Authority (SEIAA), Ministry of Environment, Forest and Climate Change (MoEF&CC) only after collecting the balance fees from the Project Proponent(s).
6. The amount shall be remitted in the form of Demand Draft in favour of 'The Member Secretary, Puducherry Coastal Zone Management Authority, Puducherry'.
