The modified / revised fee structure for issuance of CRZ clearance is subject to the following conditions:

- 1. The fee structure is applicable to all Government and Private Investment Projects in the U.T. of Puducherry.
- 2. This order takes immediate effect from the date of issue.
- 3. For residential buildings the concerned Planning Authorities while issuing clearances may collect the prescribed fees stated above and forward it to the Puducherry Coastal Zone Management Authority on monthly basis.
- 4. The Project Proponent(s) shall pay only 25 % of the total fees as initial payment for processing the application which is Non-refundable.
- 5. The Project Proponent(s) shall pay the remaining 75% of the total fees, once the proposal is cleared / recommended by PCZMA.
- 6. CRZ Clearance / Recommendation to Regional Planning Authorities; Ministry of Environment, Forest and Climate Change (MoEF&CC) for clearance to be issued by PCZMA after collecting the balance fees only.
- 7. The amount shall be remitted in the form of Demand Draft in favour of 'The Member Secretary, Puducherry Coastal Zone Management Authority, Puducherry'.
