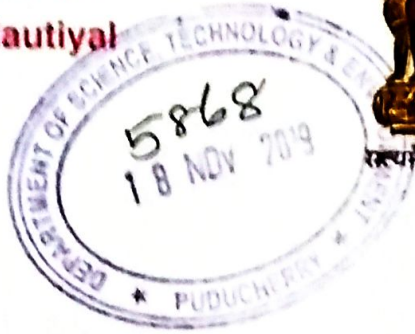

As you are aware, the CRZ Notification, 2011 are being followed for appraisal and clearances thereof for development projects in CRZ areas, pending updation/revision of the CZMPs of the coastal districts under the provisions of the CRZ Notification, 2019.

2. This Ministry has observed that the State Coastal Zone Management Authorities are taking up project proposals for recommendation of CRZ clearances to this Ministry without the statutory documents as prescribed in para 4.2 of the CRZ Notification, 2011.

3. The Coastal Zone Management Authorities are requested to be mindful that the CRZ map in 1:4000 scale received from the project developer shall indicate the project layout superimposed on the map. The map shall also indicate demarcation of HTL, LTL, ESA, CVCA, other regulatory lines viz. 200 m, 500 m, CRZ boundary lines in case of tidally influenced water bodies, estuaries etc. in consonance with the approved Coastal Zone Management Plan (CZMP) of the area/region.

4. The Coastal Zone Management Authorities are also requested to ensure that the project proposals received for CRZ clearances are complete in all respect before taking up the proposal to their respective Committees and subsequently furnishing their recommendations to this Ministry.

As per the Ministry of Environment, Forest & Climate Change (MoEF&CC) communication vide reference cited above, all the projects proposals which falls under CRZ Notification, 2011 and submitted to Puducherry Coastal Zone Management Authority (PCZMA) shall be complete in all respects as per para 4.2 of CRZ Notification, 2011.

List of enclosures for obtaining CRZ clearance as per para 4.2 of the CRZ Notification, 2011 are as follows:

- (i) The project proponents shall apply with the following documents seeking prior clearance under CRZ notification to the concerned State or the Union territory Coastal Zone Management Authority -
  - a) Form-1 (Annexure-IV of the CRZ Notification, 2011).
  - b) Rapid EIA Report including marine and terrestrial component expect for construction projects listed under 4 (c) and (d).
  - c) Comprehensive EIA with cumulative studies for projects in the stretches classified as low and medium eroding by MoEF based on scientific studies and in consultation with the State Governments and Union territory Administration.
  - d) Disaster Management Report, Risk Assessment Report and Management Plan.
  - e) CRZ map indicating HTL and LTL demarcated by one of the authorized agency (as indicated in para 2) in 1 : 4000 scale.
  - f) Project layout superimposed on the above map indicated at (e) above.
  - g) The CRZ map normally covering 7km radius around the project site.
  - h) The CRZ map indicating the CRZ-I, II, III and IV areas including other notified ecologically sensitive areas;



- i) No Objection Certificate from the concerned State Pollution Control Boards or Union Territory Pollution Control Committees for the projects involving discharge of effluents, solid wastes, sewage and the like.

Only proposals that are in complete form along with necessary documents, details and fees will be appraised by PCZMA and subsequently, recommended to the Respective Regional Planning Authorities, State Environment Impact Assessment Authority (SEIAA) and Ministry of Environment, Forest & Climate Change (MoEF&CC) based on the requirement. The proposals which are not in complete form will be duly returned back to the project proponent within 30 days of receipt of application, which is for strict compliance.


