OFFICE MEMORANDUM

Subject: Submission of Half Yearly Compliance report through the dedicated module in PARIVESH 2.0

In pursuance of the 'Digital India' initiative and embodying the ethos of Minimum Government and Maximum Governance, the Ministry of Environment, Forest and Climate Change (MoEF&CC) launched the PARIVESH portal (Pro-Active and Responsive facilitation by Interactive, Virtuous, and Environmental Single Window Hub) in August 2018.

2. Building on the success of the existing portal, the Ministry has now expanded the scope of PARIVESH portal to an enhanced version, PARIVESH 2.0. This upgraded version continues to provide a "Single Window" solution for the administration of effective environmental regulations and monitoring mechanisms.

3. In accordance with the EIA Notification 2006 and as amended, Project Proponents are required to submit Half-Yearly Compliance Reports (HCR) on the environmental conditions, to the regulatory authority concerned, on 1st June and 1st December of each calendar year. To streamline this process, a dedicated functionality has been developed and rolled out in PARIVESH 2.0 for the online submission of these Half-Yearly Compliance reports.

4. Earlier, Ministry vide Office Memorandum (OM) dated 14th June 2022 directed all the Project Proponent to submit the HCR on the environmental conditions prescribed in the prior environmental clearance letter(s) through newly developed compliance module in the PARIVESH Portal from the respective login. Similar functionality has also been developed in PARIVESH 2.0, accordingly all the Project Proponents are directed to submit their Half Yearly Compliance reports strictly through the dedicated module of PARIVESH 2.0.

5. Project Proponent are hereby directed to ensure that their Half Yearly compliances on the environmental conditions stipulated in the Environmental Clearance (EC) letter are submitted in a timely manner on or before 1st June and 1st December of each calendar year.
