#### **NOTIFICATION**

In exercise of the powers conferred under Clause-(e) of sub-rule (2) of Rule 9 of the Rules and Regulations of the Puducherry Council for Science and Technology (Society registered under the societies Registration Act,(1860), Puducherry notified in G.O..Ms.No.9/Envt/98, dated 23<sup>rd</sup> June 1998, of the Chief Secretariat (Envt), Puducherry and published in the Extraordinary Gazette No.121, dated 29.09.1998, the Puducherry Council for Science and Technology, Puducherry hereby makes the following regulations for recruitment to the Group 'B' posts of Scientific Officer, Technical Assistant, Assistant and Group 'C' post of Data Entry Operator in the Puducherry Council for Science and Technology, as approved by the Council, namely:-

1. Short title and commencement.- (1) These regulations may be called the Puducherry Council for Science and Technology, Puducherry (Method of Recruitment, Terms and Conditions of Service of Officers and other Employees other than Member Secretary) Regulations, 2017.

(2) They shall come into force on and from the date of their Notification by the Puducherry Council for Science and Technology with the approval of its Council.

2. **Definition.-** In these regulations, unless the context otherwise requires, -

- (a) "Appellate Authority" means the Chairman, Puducherry Science, and Technology Council, Puducherry for Group 'B' and 'C' posts.
- (b) "Chairman" means the Chairman of the Council of Executive Committee formed under the rules and regulation of Puducherry Council for Science and Technology Society, Puducherry.
- (c) "Council" means the Puducherry Council for Science and Technology, Puducherry, constituted by the Department of Science and Technology, New Delhi, Ministry of Science and Technology, Govt. of India, New Delhi;
- (d) "Employee" means any officer or servant appointed as staff of the Puducherry Council for Science and Technology Society shown in column (1) of 'schedule';
- (e) "Member Secretary" means the Member Secretary of the Council;
- (f) "Post" means a post created by the council as per rule 9 (2) (j) of the rules and regulation of the Puducherry Council for Science and Technology Society.

<sup>3.</sup> Officers and other employees of the Committee.- The nature and categories of officers <sup>and</sup> other employees of the Council and the Pay Band and Grade pay / Pay scale there of shall <sup>be as</sup> specified in Schedule appended to these regulations.

Number of Post, Classification, Pay Band and Grade pay/Pay scale, Method of Recruitment, Age-limit and Other Qualifications.- The name of the posts, their number, classification, Pay Band and Grade pay /Pay scale, the method of recruitment, age-limits, qualifications and other matters relating to the said posts, shall be as specified in column [(2) to (12)] of the Schedule aforesaid.

6. Pay, allowances, leave and other conditions of service of officers and other employees.-

- (1) The Pay Band and Grade pay /Pay scale of employees of the Council shall be as specified in column (4) of Schedule.
- (2) Without prejudice to the rules and regulations of the Puducherry Council for Science and Technology Society, the Council shall regulate the conditions of service in respect of allowances, leave, probation, seniority, promotion, joining time, joining time pay, conduct, discipline, age of superannuation, retirement benefits, Leave Travel Concession, Children Education Allowance and reimbursement of tuition fees, advances including interest bearing advances, medical facilities and other conditions of service of its staff and employees.

# 7. Appointing Authority.-

- All appointments to Group 'B' posts shall be made by the Chairman with the prior approval of the Council of the Puducherry Council for Science and Technology, Puducherry.
- (2) All appointments to Group 'C' posts shall be made by the Member Secretary with the prior approval of the Council of the Puducherry Council for Science and Technology, Puducherry.

## Disqualifications: No Person,-

8.

- (a) Who has entered into or contracted a marriage with a person having a spouse living; or
- (b) Who, having a spouse living, has entered in to a contracted a marriage with any person,

Shall be eligible for appointment to the said post;

Provided that the Chairman of the Puducherry Council for Science and Technology may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and there are other grounds for so doing, exempt any person from the operation of this rule.

9. **Matters with respect to which no provision has been made.** Matters relating to the conditions of service of officers and other employees with respect to which no provision has been made in these regulations, shall be referred to the Council for its decision.

10. **Power to relax.** Where the Council is of the opinion that it is necessary or expedient so to do, it may, by order and for reasons to be recorded in writing, relax any of the provisions of these regulations with respect to any class or category of persons.

11. **Saving.-** Nothing in these regulations shall affect reservations, relaxation of agelimit and other concessions required to be provided for the Scheduled Castes, Ex-servicemen, and Other Backward Classes, and other special categories of persons in accordance with the orders issued by the Government of Puducherry from time to time in this regard as approved by the Council...

12. This has been issued with the clearance of Department of Personnel and Administrative Reforms (Personnel Wing), Puducherry, Law Department and approved by the Council in its 5<sup>th</sup> General Body Meeting held on 02.02.2017 of the Puducherry Council for Science & Technology, Puducherry.
