With reference to the above-mentioned subject, it is informed that the Ministry of Environment, Forests and Climate Change (MoEF&CC), Government of India (GoI), has notified the Coastal Regulation Zone (CRZ) Notification vide reference (1) and (2) cited above to regulate activities in the coastal area. The permitted and prohibited activities are mentioned in the CRZ Notifications.


GoI has classified and declared the coastal areas into different Zones viz., CRZ-I, CRZ-II, CRZ-III and CRZ-IV and imposes certain restrictions on the setting up and expansion of industries, operations or processes and the like in the CRZ area. Only those activities which are permitted as per the Notification can be carried out in the said area with prior recommendations from the Puducherry Coastal Zone Management Authority (PCZMA). The Coastal Zone Management Plan (CZMP), CRZ Notifications, Maps can be downloaded from the following web link: <https://dste.py.gov.in/pczma/Map.html>.

Depending upon the projects / activities as per CRZ Notification, clearances will be issued either by MoEF&CC / State Environment Impact Assessment Authority (SEIAA) / Planning Authorities with the recommendations of PCZMA. Projects / activities executed in CRZ area by Government Departments / Authorities without the recommendations of PCZMA, leads to violation of CRZ Notification and actions as per the provisions of the Acts, Rules and Notifications.

Hence, all the Departments / Authorities are advised to obtain necessary prior recommendations from PCZMA as envisaged in the Notification before carrying out any such permitted activity in CRZ area. This is for strict compliance.
