The Member Secretary of the Regional Coastal Zone Management Committee (RCZMC), Puducherry, warmly welcomed all the esteemed members of the committee and provided an introduction to the Coastal Regulation Zone (CRZ) Notification, 2011.

Shri. A. Kulothungan, IAS, District Collector-cum-Chairman (RCZMC), Puducherry has said to the committee to effectively implement and enforce the CRZ Notification, 2011 and to take necessary action against the CRZ violators. The Chairman RCZMC, Puducherry, outlined the key functions and powers vested in the RCZMC, emphasizing its role in ensuring the effective implementation of the CRZ regulations, monitoring compliance, and supporting coordinated efforts for coastal conservation and management.

Discussion on CRZ violations in Puducherry:

Coastal Management Consultant (CMC), Puducherry Coastal Zone Management Authority (PCZMA), Puducherry made a detailed presentation on the CRZ violations in the Puducherry region. The following violation cases were discussed during the meeting:

- 1. Allegation against Development of Beach for promoting tourism facilities at R.S. No. 54 pt, Poornakuppam Village, Ariyankuppam Revenue Village, Puducherry by Department of Tourism, Government of Puducherry.
- 2. Violation of Environmental Clearance conditions by M/s. RKN Beach Resort (Old Kailash Beach Resort), Poornankuppam, Ariyankuppam Commune Panchayat, Puducherry.
- 3. Unauthorized construction of Resort building in the name of M/s. Chan Beach Resort at R.S. No. 186, and R.S. 188, Narambai Village, Pillaiyarkuppam Revenue Village, Bahour Commune Panchayat, Puducherry.
- 4. Unauthorized construction of two storeyed Resort building in the name of M/s. Good Day Club Resort at R. S. No. 186, 188, 452 and 453, Thirumal Beach land, Narambai Pillaiyarkuppam Revenue Village, Bahour Commune Panchayat, Puducherry.
- 5. Unauthorized construction of three storeyed Resort building in the name of M/s. Pranaav Beach Resort at R.S. No. 186 and 188, Narambai, Pillaiyarkuppam Revenue Village, Bahour Commune Panchayat, Puducherry.
- 6. Unauthorized construction of residential building at R.S. No. 193, 68, Pachaivazhiamman Koil Street, Beach Road, Vaithikuppam, Puducherry Municipality, Puducherry.
- 7. Public Complaint against Development of Beach for promoting tourism facilities in Dubrayapet (M/s. Pondy Marina Beach), Puducherry Municipality, Puducherry.
- 8. Destruction of Mangrove at Thengaithittu, Puducherry Municipality, Puducherry w.r.t. O. A No. 231 of 2024 before the Hon'ble National Green Tribunal (Southern Zone), Puducherry.
- 9. Unauthorized construction in the name of Sri Sundara Moorthy Vinayagar Temple at R. S. No. 162/6. (G.P) land at Kalapet Revenue Village, Oulgaret Municipality, Kanapathichettikulam, Puducherry.

After due deliberation, the committee decided to constitute a Sub-Committee to inspect and assess the above said CRZ violations with the mandate to continue its work as necessary for ongoing monitoring and compliance. The Sub-Committee will be formed as follows:
