Agenda Item No.II-Cases for Issue of NOC/Consent to Establish

Agenda Item No. 1: Issue of Air and Water Consent Orders (Renewal) to M/s. Chemfab Alkalis Ltd., Kalapet, Puducherry for manufacturing Caustic Soda - 125 TPD and its allied products.

The proposal for renewing the Air and Water Consent Orders to M/s. Chemfab Alkalis Ltd., for manufacturing Caustic Soda - 125 TPD and its byproducts was discussed by the Committee in detail.

The Committee was informed that the specific condition of installation of Desalination Plant with reference to previous Consent Orders issued by PPCC is long pending and yet to be complied by the unit. The Committee was also informed that the unit is not manufacturing Caustic Soda Pellets.

Considering the above, the Committee after due deliberation decided to renew the Air and Water Consent Orders of the unit up to 31<sup>st</sup> March 2019 to manufacture Caustic Soda - 125 TPD and its by products except Caustic Soda Pellets, with the condition that the unit shall source its complete industrial water requirement either from Treated Sewage Water of Common Sewage Treatment Plant, Karuvadikuppam (or) install Desalination Plant within 6 months period. The unit shall submit an undertaking with a Bank Guarantee of Rs. 25 Lakhs valid up to 31<sup>st</sup> March, 2019 in this regard, failing to utilize alternative source of water requirement within the said period will lead to forfeiting of Bank Guarantee.

Agenda Item No. 2: Issue of NOC to M/s. Karaikal Port Pvt. Ltd., Keezhavanjore Village, T.R.Pattinam Commune, Karaikal, to permit to handle Sand – 1.0 MMTPA, consequent to in-principle clearance accorded vide 157<sup>th</sup> Meeting of this Committee held on 05.03.2018 and compliance by the unit, towards the corresponding conditions imposed by this Committee.

The Committee heard the proposal of the project agency and discussed the subject in detail. The Committee after due deliberation decided that a Team of officials of this Committee shall visit V.O. Chidambaranar Port Trust, Tuticorin and Chennai Port Trust, Chennai for assessment of pollution mitigation measures provided while handling the sand and shall submit a report of to this Committee for further consideration of the proposal.

Agenda Item No.3: Issue of Authorisation for collection and transportation of Hazardous and other waste generated from Puducherry to TSDF of M/s Mother Earth Environ Tech Private Limited., Harohalli, Kanakapura (Tq.), Karnataka, under H&O Waste (Management and Transboundary Movement Rules, 2016.

The Committee heard the proposal of the project agency and discussed the subject in detail. The Committee after due deliberation decided to clear the proposal, subject to the following conditions:

- i) The unit shall inventorieze the land fillable HW generating units and its quantity in the U.T. of Puducherry.
- ii) The unit shall obtain NOC from KSPCB, Karnataka.
- iii) The unit shall follow the guidelines of CPCB for transportation of HW.
- iv) The transportation vehicle shall be authorized by the respective State Pollution Control Board / Committee.
- v) After analysis of calorific value of HW, the unit shall ensure for transportation for final landfilling in their facility.
- vi) Manifest in Form-10 and Annual Returns in Form-4 shall be submitted to PPCC.
