GOVERNMENT OF PUDUCHERRY CHIEF SECRETARIAT (ENVIRONMENT)

(G.O. Ms. No. 10/ENVT-2025, Puducherry, dated 20th June 2025)

NOTIFICATION

The Central Pollution Control Board (CPCB), in its report published in January 2025, revised the methodology for classification of Industrial Sectors into Red, Orange, Green, White and Blue categories, with the objective of streamlining the Consent to Establish (CTE) and Consent to Operate (CTO) processes across all States and Union Territories.

2. Further, as per Central Pollution Control Board communication *vide* Letter No. CP-18/1/2023-IPC-VI-HO-CPCB-HO, dated 12-02-2025, all State Pollution Control Boards (SPCBs) and Pollution Control Committees (PCCs) have been directed to adopt the revised classification methodology and incorporate any left-out or new industrial sectors in their categorization list.

3. The revised classification is based on the Pollution Index (PI) of each Industrial activity, categorized as follows:

- * Red : $PI \geq 80$
- * Orange : $55 \leq PI < 80$
- * Green : $25 \leq PI < 55$
- * White : $PI < 25$ [Exempted from Consent to Establish (CTE) and Consent to Operate (CTO)]
- * Blue : Essential Environmental Services

4. Based on this methodology, Central Pollution Control Board has classified a total of 419 Industrial sectors and sub-sectors as follows:

- * Red : 125
- * Orange : 137
- * Green : 94
- * White : 54
- * Blue : 9

5. Accordingly, the Puducherry Pollution Control Committee (PPCC) has reviewed and classified all existing, left-out, and new industrial sectors operating in the Union Territory.

6. A total of 1324 Industrial sectors have been reclassified by Puducherry Pollution Control Committee (PPCC) as follows:

- * Red : 143
- * Orange : 206
- * Green : 211
- * White : 752
- * Blue : 12

7. The Government of Puducherry has examined the matter in detail and hereby notifies the revised classification of industries into Red, Orange, Green, White and Blue categories as outlined in the Annexure to this Notification with the view to institutionalize deregulation measures in the Union territory of Puducherry as one of the key reform measures aimed at promoting industrial and commercial investments and ventures.

8. The Puducherry Pollution Control Committee (PPCC) shall constitute a Committee for any addition, deletions or modifications to the sectors covered in the current list. The Committee shall make suitable recommendations in line with the Central Pollution Control Board (CPCB) Report on Classification of Industrial Sectors, January 2025.

9. Further, in line with the principles of Ease of Doing Business and recommendations of Central Pollution Control Board (CPCB), White Category Industries, which are non-polluting in nature, are hereby exempted from obtaining Consent to Establish (CTE) and Consent to Operate (CTO) under the Water (Prevention and Control of Pollution) Act, 1974 and the Air (Prevention and Control of Pollution) Act, 1981. However, such industries shall be required to submit a self-declaration to Puducherry Pollution Control Committee confirming compliance with relevant environmental rules and regulations. The Puducherry Pollution Control Committee (PPCC) shall maintain and periodically update a list of such units and ensure that only the declared activities are undertaken by them.

10. The Notification shall come into force with immediate effect.
