CIRCULAR

Sub: PPCC – Filling up of one post of Scientist 'C', Group 'A' (Level 10 of Pay Matrix) in the Puducherry Pollution Control Committee (Autonomous), Puducherry on deputation basis – Re-Notification - Reg.

It is hereby re-notified the vacancy of one post of Scientist 'C' in the Puducherry Pollution Control Committee (Autonomous), Puducherry, which is classified as Group 'A' carrying pay in Level 10 of Pay Matrix to be filled up on Deputation basis (Including short term contract). This re-notification is due to non-filling up of post on administrative reasons against previous notification dated 16.03.2023 inviting application from the eligible officials for filling up the post of Scientist 'C'.

- 2. As per the Recruitment Rules for the post of Scientist 'C', the method of recruitment is by Deputation (including short-term contract)/Promotion failing which by direct recruitment. The details of the eligibility criteria are as follows:
 - Officers of the Central Government / State Government / Union Territory Administrations or Central / State / Autonomous or Statutory Organizations / Recognized Research Institutions / Public Sector Undertakings / Universities.
 - (i) holding analogous posts on regular basis; or
 - (ii) having at least 2 years regular service in posts in Level-8 of Pay Matrix; or
 - (iii) having at least 3 years regular service in posts in Level-7 of PayMatrix;
 - 2. The Scientist 'B' in the Puducherry Pollution Control Committee with 3 years regular service in the post will also be considered and in case, he is selected for appointment to the post, the same shall be deemed to have been filled by promotion.

(Period of deputation including the period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other organisation or department of the Central / State Governments shall ordinarily not exceed three years).

Note: (1) The Departmental officers in the feeder category who are in direct line of promotion shall not be eligible for consideration for appointment on deputation. Similarly, the deputationists shall not be eligible for consideration for appointment by promotion.

Note: (2) The maximum age limit for appointment by deputation shall be not exceeding 56 years on the closing date for receipt of applications.

Educational and other Qualification

- (i) Master's degree in Chemistry/Bio-Chemistry/Micro-Biology/Environmental Science/Ecology from a recognized University.
- (ii) Five years experience in Environmental Quality Management and Pollution Control Activities or research work in the relevant fields.
- **Note:** (1) The qualifications are relaxable at the discretion of the Competent Authority/Committee in the case of candidates otherwise well qualified.
- **Note:** (2) The qualification regarding experience is relaxable at the discretion of the Committee in the case of candidates belonging to the Scheduled castes or scheduled tribes if at any stage of selection the Committee is of the opinion that sufficient number of candidates from these communities possessing the requisite experience are not likely to be available to fill up the vacancy reserved for them.

- 3. The Officers selected on deputation for the post will be governed by the terms and conditions laid down in Government of India, Department of Personnel and training O.M. No. 6/8/2009-Estt. (Pay II) dated 17th June 2010 as amended from time to time. Place of posting will be in Puducherry. No provision for reservation exists to the post to be filled up on deputation basis.
- 4. It is requested that this circular may be given wide publicity by circulation to all offices / Organizations etc. The applications (in duplicate in the proforma as published in the official website https://dste.py.gov.in and https://dste.py.gov.in along with the complete Annual Performance Appraisal Report (APAR) Dossiers for last five years of the eligible officers who could be spared in the event of their selection, may be forwarded by the respective employer to 'The Member Secretary, Puducherry Pollution Control Committee, PHB Building, Anna Nagar, Puducherry 605 004' within 6 weeks i.e., 42 days from the date of publication of this Re-notification in the Employment News. Besides, the following information / documents may also be sent along with application:
